To Whom It May Concern:

Regarding Buy America compliance for Gibson Stainless & Specialty, Inc.'s (GSS) products, the following is provided:

In accordance with the requirements of the Buy America provision of the Surface Transportation Assistance Act of 1982, codified in 23 U.S.C. 313 for the FHWA and 49 U.S.C. 5323(j) for the FTA<sup>1</sup>, all manufacturing processes for these stainless steel products took place in the U.S., and all components are of U.S. origin. That is, the following GSS products meet all Buy America requirements of the Act:
